Her philanthropic work has included advocating for public education, foster kids, improved mental health care and alternatives to incarceration.

in the United States (its budget is about \$2.4 billion). The department operates programs in more than 85 sites, and provides services through contract programs and department staff at approximately 300 sites co-located with other county departments, schools, courts and various organizations. Each year, the department contracts with close to 1,000 organizations and individual practitioners to provide a variety of mental health-related services. On average, more than 250,000 county residents of all ages are served every year.


Ralphs Community Rewards Program



#### **Evening Books October 22**




With this award-winning first novel, Louise Penny introduces an engaging hero in Inspector Gamache, who commands his forces with power, ingenuity, and charm.

By Neil Simon, America's great comic playwright, this memory play is set in Yonkers in 1942. Bella is thirty-five years old, mentally challenged, and living at home with her mother, stern Grandma Kurnitz. As the play opens, ne'er-do-well

son Eddie deposits his two young sons on the old lady's doorstep. He is financially strapped and taking to the road as a salesman. The boys are left to contend with Grandma, with Bella and her secret romance, and with Louie, her brother, a small-time hoodlum in a strange new world called Yonkers.

Lost in Yonkers won a Pulitzer Prize for drama and a Tony Award, Best Play

# **Public Policy**

Three bills dealing with the California Fair Employment and Housing Act (FEHA) passed both California houses and are on Governor Brown's desk! Big thanks to everyone who called and tweeted at lawmakers.

• AB 1870- Employment discrimination: limitation of actions. Discrimination against or harassment of employees is unlawful. Claims of discrimination or harassment must be filed within one year. AB 1870 would extend the period to 3 years for complaints alleging employment discrimination.

• AB 3080- Employment discrimination: enforcement. This bill would prohibit any employer from interfering with an employee's, employment applicant's, or independent contractor's ability to exercise any right, forum, or procedure for a violation of the FEHA or other specific statutes governing employment.

• SB 1300 - Unlawful employment practices: discrimination and harassment. The bill would prohibit an employer from preventing an employee to disclose information about unlawful acts in the workplace. The bill also would extend employers' responsibility to take immediate and appropriate corrective action with respect to any type of harassment prohibited under FEHA (not just sexual harassment). This bill also would authorize an employer to provide bystander intervention training to their employees. This bill also would prevent a prevailing defendant from being awarded fees and costs unless the court finds the action was frivolous, unreasonable, or groundless when brought or that the plaintiff contin-Ivanna ued to litigate after it clearly became so.


