# Student Loan Forgiveness Gets Help

Attorneys general from 19 states, plus the District of Columbia, sued U.S. Secretary of Education Betsy DeVos and the U.S. Department of Education for delaying a borrower protection rule that was scheduled to take effect beginning July 1.

The lawsuit was filed in federal district court in Washington, D.C. and alleged that DeVos illegally delayed the implementation of the borrower defense to repaying rule, which was intended by the Obama administration to make it easier for defrauded student loan borrowers to receive student loan debt

The attorneys general claimed that DeVos violated the Administrative Procedures Act because she did not meet the standard for a delay, give proper notice or afford adequate time for public comment. The lawsuit asked the court to implement the borrower defense rule promptly.

In a 57-page legal opinion, U.S. District Judge Randolph Moss wrote that the Education Department's rationale was arbitrary and capricious.

#### **Borrower Defense To Repaying**

Borrower Defense To Repaying allows students to have their federal student loans forgiven if a school employed illegal or deceptive practices to encourage the students to borrow debt to attend the school.

The judge's ruling does not require the rule to be reinstated, but remedies are expected to follow.

DeVos believes that the borrower defense to repaying rule and another borrower protection rule known as the gainful employment rule - is confusing and unfair to both students and schools. While critics view the Education Department's delay as a win for the for-profit college industry, DeVos has said that the rule changes will still help students who are victims of fraud.

"Fraud, especially fraud committed by a school, is simply unacceptable," DeVos said in a statement in June. "Unfortunately, last year's rulemaking effort missed an opportunity to get it right. The result is a muddled process that's unfair to students and schools, and puts taxpayers on the hook for significant costs."

DeVos said she wants to strike a fair balance between protecting students from predatory practices and creating balanced rules to which colleges can adhere.

"It's time to take a step back and make sure these rules achieve their purpose: helping harmed students," DeVos said. "It's


time for a regulatory reset. It is the Department's aim, and this Administration's commitment, to protect students from predatory practices while also providing clear, fair and balanced rules for colleges and universities to follow."

#### What This Means

How these rules change - and by how much - will be watched closely, particularly with respect to:

- any revised definitions of fraud and deceptive practices;
- how gainful employment metrics will be calculated;
- how taxpayers will save money and how much; and
- what are the litmus tests for borrowers to have their student loans forgiven or discharged, among other key points.

### Fair Employment & Housing Act Reinforced

Senate Bill 1300, regarding unlawful employment practices: discrimination and harassment was signed by the governor and is now Chapter 955 of the Statutes of 2018 and will take effect January 1, 2019. The bill was one of three supported by AAUW California. The governor vetoed the other two bills, Assembly Bills 1870 and 3080, which also would have amended the California Fair Employment and Housing Act. ### **Author's Luncheon**

Jorja Leap, Ph.D., M.S.W. Adjunct Professor Executive Director, Social Justice Research Partnership

Jorja Leap has been a professor at the University of California, Los Angeles (UCLA) Luskin School of Public Affairs since1992. As an anthropologist and recognized expert in gangs, violence, and trauma, she has worked both nationally and internationally in violent and post-war settings throughout her career.

Dr. Leap applies a multi-disciplinary, community-based approach in her research and developmental efforts. As an author she is engaged with her subjects in ways that respect and involve them, but do not add to their marginalization. Her next book will focus on the issues of women, gangs and trauma and will be published by Beacon Press in 2020. This current work focuses on a group often overlooked: Women—in gangs, multi-cultural community justice settings, criminal justice and prison reform—specifically the dilemmas these women face reentering society after their incarceration.

Dr. Leap has been deeply involved with The California Endowment Building Healthy Communities Initiative, creating and implementing participatory evaluation within underserved and marginalized populations whose service providers are funded by TCE. This work also gave rise to a case study of A New Way of Life, an innovative prison reentry program for women based in South Los Angeles. As a result of this effort, Dr. Leap is currently engaged in a replication study of A New Way of Life, working to develop a national model for reentry "safe houses" for women.

Dr. Leap serves in many capacities: As policy advisor on Gangs & Youth Violence for Los Angeles County; as an expert reviewer for the National Institute of Justice; and as Principal Investigator for an evaluation of the Los Angeles Police Department Community Safety Partnership. She is the qualitative research director for the Los Angeles Mayor's Office Gang Reduction Youth Development (GRYD) Program. She is also the advisor on Gang Issues to the State of Califor-

nia and Board of State & Community Corrections (BSCC). She offers expert testimony on the impact of violence and trauma in death penalty and capital cases for the Federal Public Defender and other defense attorneys.

Drawing upon her research, Dr. Leap has provided commentary on numerous TV, radio and newspaper stories about gangs. In 2009, she began a ten-year longitudinal study of Homeboy Industries, focusing on the life histories of program participants as they encountered the dual challenges of leaving gang life and reentering mainstream society. This work was expanded to Homeboy Industries' social enterprise model. Dr. Leap's study concentrated on the Homegirl Café and its training program for women.

Since 2011, Dr. Leap has served as the Executive Director of the UCLA Social Justice Research Partnership, which is affiliated with the United Nations World Health Organization (WHO) Violence Prevention Alliance. As part of her action research efforts, Dr. Leap has authored numerous reports, articles, and book chapters as well as the book, *Jumped In: What Gangs Taught Me about Violence, Love, Drugs and Redemption*, published by Beacon Press in 2012, with all proceeds going to Homeboy Industries. More recently she authored the book, *Project Fatherhood: A Story of Courage and Healing in One of America's Toughest Communities*, published by Beacon Press in 2015, with all proceeds going to Project Fatherhood.


