Come listen to AAUW Fellow, Megan Chung, enlighten us on the exciting work she is doing at USC. Her work with FELs, free electron lasers, is new and stimulating. Megan's work will further advance future medical devices. She can elaborate on her abstract better than I!



Low Power Tunable Flux Sources for Free Electron Laser Steering and Focusing and Advancements in Medical Devices Free electron lasers (FELs), a laser unique in its high light intensity, benefit applications ranging from clearer microscopic imaging for material research to more precise medical imaging and radiation treatment. However, current free electron laser technology requires large facility space and equipment kilometers in size. This results in the technology being very limited. Less than 10 facilities exist in the United States and demand largely exceeds the facilities and their available use times. To increase distribution and access of FELs, especially in small medical devices, research minimizing FEL systems to a chip-scale is growing. This study focuses on designing more efficient, more miniaturized quadrupole magnets, a crucial focusing element of FEL beams. The study utilizes COMSOL, a finite element analyzer, to simulate and finetune a quadrupole magnet design almost a thousand times smaller than current technology that takes advantage of permanent magnet, magnetoelastic, and piezoelectric materials to create a low power, tunable FEL focusing element to bring to reality chip-scale FEL systems.

Membership Corner

TIPS FOR AVOIDING EMAIL SCAMS THAT APPEAR TO COME FROM FRIENDS OR FAMILY

I recently received an email from our President, Marilee Wood, requesting donations in the form of gift cards. Of course it was not from her. I have also received numerous calls from my clients asking me about text messages/emails from UPS, toll road collection companies and or calls claiming that they owed fines. All these methods of communication are called PHISHING SCAMS.

DO NOT reply to the message and do NOT click on any links or attachments. Here are four tips to recognizing and avoiding email scams.

- 1. Be suspicious of unusual requests. If a friend or family member suddenly emails you asking for money, gift cards, or sensitive information, be skeptical.
- 2. Look at the writing style. Proceed with caution if you encounter unusual wording, spelling or grammatical errors, or phrasing that just doesn't "sound like" the person.
- 3. Stay calm. Scammers frequently rely on urgent language to drive immediate action. Do not rush to respond to the request until you determine its validity.
- 4. Look carefully at the sender's email address. Many email systems just show you the sender's display name, which is easy to manipulate. The email address itself must be inspected. In most systems you can hover your mouse over the sender's name to reveal their email address. Check the email address carefully. Frequently, the email address is entirely wrong and easy to dismiss as fraudulent. In more sophisticated scams, the email address may be only slightly different.
- If you have identified the email address as incorrect, then delete the message (optionally, report as spam).
- If the sender is a friend, call the friend to verify.
- If you receive a call that there is a warrant for your arrest and that you need to pay money to avoid arrest, it is a scam.
- If you receive a call from a person purporting to be a bail bonds man or just someone saying that your loved one has been arrested and you need to pay money to get loved one released, do not panic. Get the name of the person calling you and a call back number. If they do not give you the information, it is a scam. If they do give you their information, it does not mean it is legitimate. Hang up, call the loved one or reach out to family to verify.
- If you are uncertain, reach out to your local law enforcement agency or contact me.

With a bit of knowledge and careful attention, it is possible to avoid many email scams.

PROJECT 2025 IS BECOMING REALITY AND DEI IS UNDER FIRE Project 2025 is Becoming Reality. Take Action to Fight Back!

As Co-Directors Amy Hom and Missy Maceyko outlined in a <u>webinar</u> in October 2024, the objectives of Project 2025 directly counter the Public Policy Priorities of AAUW California. With federal policy pronouncements and changes taking place at a head-spinning pace since

January 20, 2025, it is clear that there is a concerted effort by a number of coalitions in the federal government to make Project 2025 become reality. For example:

- The Executive Order declaring that there are "only two genders, male and female".
- The Executive Order eliminating federal funds for schools that recognize transgender identities or teach about structural racism, white privilege, and unconscious bias.
- The Executive Order directing federal agencies to look for ways to expand access to private school vouchers.
- The Executive Order rescinding a dozen Biden-era executive actions supporting racial equity and combating discrimination against gay and transgender people.
- The Office of Management and Budget ordered freezing all federal financial assistance (since rescinded but with a standing order for agencies to restrict DEI programming and "woke gender ideology").
- The Executive Order withdrawing the United States from the 2015 Paris Agreement that seeks to avoid the worst impacts of the climate crisis.

While this may seem overwhelming, there are also coalitions that are pushing back in a number of ways, including <u>through legal challenges</u>. AAUW California is building out our own action-items database, which will go live for you this spring. For now, we ask you to **take action** by choosing **one self-focused**, **one other-focused**, **and one political-focused** item from the list below.

Self-Focused: Education

- rewatch the webinar from the fall, as needed, to get a sense of what Project 2025 is/does and/or read the <u>document</u> itself.
- read the legal challenges linked above to better understand how organizations are working to fight back.

Other-Focused: Education & Connection

• whatever you take away from your homework in self-education--be sure to tell one friend about what you learned. You can do this over lunch.

Politically-Focused: Outreach to Senators

School Board Project: The School Board Project is now ready to begin the next phase, which will entail monitoring school boards for compliance to California law. Please take a moment to complete the survey which arrived in all members inbox on February 4th to help us get a better picture of where we are following the recent elections and where we need to focus to provide the best tools to help our branches engage at the local level.

AAUW Public Policy Priorities: As most of you know, AAUW California is currently undergoing the biennial review and update of our Public Policy Priorities (PPPs). The California Public Policy Committee is working together to consider all of your feedback and, based on this, will release proposed updates to members for a vote this spring. Your input and this process are important as these Priorities shape our actions as an organization.

The same is true of AAUW National, which is also in the process of updating its Public Policy Priorities (PPPs) for 2025-2027. Proposed changes to AAUW National's PPPs were shared with membership in early January, along with an invitation for all members to review and comment. Over the course of the last month, several members who have reviewed these proposed changes, alongside AAUW National's other public statements and strategy documents, have expressed concern that AAUW National appears to be narrowing its focus to higher education, and in doing so, moving away from other priority areas.

We want to address this concern and provide some insight into AAUW National's overall strategy, as reported. With all of the different issue-areas now under attack, AAUW National has to conserve its resources. As part of building wider coalitions with other like-minded organizations, they have made the decision to put their focus on education, where they have the most expertise and the best opportunity to make an impact. This does not mean AAUW National is abandoning its commitment to other areas, like social justice. Instead, they are strategically deciding to rely heavily on coalition partners who are leaders in these other areas. By working in a coalition, different organizations can lead in the areas where they have more expertise, with the rest of the coalition adding their collective influence. AAUW National's focus on higher education is simply direction given to the Public Policy staff regarding where to invest the majority of their time and resources.

Four eloquent high school debaters successfully participated in the first round of the American Association of University Women (AAUW) Annual California Speech Trek Contest on Saturday, February first in the Friends Room of the Monterey Park Bruggemeyer Library. Kailia Garfield, senior, Nicholas Jung, junior and Ethan Ma, freshman from Mark Keppel High School, and Natalie Chan, sophomore from Brea Olinda High School, delivered their insightful speeches on the following question: *Select one area of impact and explore the effect climate change is having on women in the USA and around the world.* The students demonstrated their grasp of the topic as they spoke with poise and confidence before family, friends and branch members.


The event, sponsored by the Alhambra-San Gabriel branch of AAUW, was moderated by Kathleen Doty, the branch's accomplished Speech Trek Coordinator. Videographer, Michael Olmos, volunteered his time to create videos of each speaker to send to Speech Trek CA.

First Place Winner, Kailia Garfield, will receive \$500. Nicolas Jung, Second Place Winner will receive \$250 and Ethan Ma, Third Place Winner will receive \$100. Gloria Ing is

the skilled and expert coach of these three debaters. Natalie Chan, Fourth Place Winner, will receive \$50. Judging the students for content, organization and delivery were Veronica Alvarez, lawyer and the branch's Membership Vice-President, Jane Anderson, past Alhambra USD board member and the branch's Fund Vice-President, and Robert Sanchez, seasoned speech and debate judge.

The Winner of the state contest will receive \$2500. The Second Place Winner will receive \$2000, and the Third Place Winner, \$1000. Fourth and Fifth Place Finalists will be awarded \$500 each. Debaters awarded honorable mention will also receive cash prizes.

Finalists from AAUW's Alhambra-San Gabriel's Speech Trek competition have placed in the top three positions seven times since Speech Trek was established in 2007. They are Peggy Truong (3rd in 2007), Tiffany Chia (3rd in 2008), Alexandra Lossada (2nd in 2009), Pavin Trinh (1st in 2013), Sharon Lu (1st in 2016), Sabrina Sy (3rd in 2017), and Elizabeth Ma (2nd in 2023).


set up the interviews and choose the campers to attend camp.

RUINED A rain forest bar and brothel in the brutally war-torn Congo is the setting for Lynn Nottage's extraordinary new play. The establishment's shrewd matriarch, Mama Nadi, keeps peace between customers from both sides of the civil war, as government soldiers and rebel forces alike choose from her inventory of women, many already "ruined" by rape and torture when they were pressed into prostitution. Inspired by interviews she conducted in Africa with Congo refugees, Nottage has crafted an engrossing and uncommonly human story with humor and song served alongside its postcolonial and feminist politics in the rich theatrical tradition of Bertolt Brecht's Mother Courage. June 1940. France has fallen to the Nazis, and Britain may be next--but to many Americans, the war is something happening "over there." Veronica Grace has just graduated from college; she and her mother, Violet, are looking for a fresh start in sunny Los Angeles. After a blunder cost her a prestigious career

opportunity in New York, Veronica is relieved to take a typing job in L.A.--only to realize that she's working for one of the area's most vicious propagandists.

Overnight, Veronica is exposed to the dark underbelly of her new home, where German Nazis are recruiting Americans for their devastating campaign. After the FBI dismisses the Graces' concerns, Veronica and Violet decide to call on an old friend, who introduces them to L.A.'s anti-Nazi spymaster.

At once, the women go undercover to gather enough information about the California Reich to take to the authorities. But as the news of Pearl Harbor ripples through the United States, and President Roosevelt declares war, the Grace women realize that the plots they're investigating are far more sinister than they feared---and even a single misstep could cost them everything.

Inspired by the real mother-daughter spy duo who foiled Nazi plots in Los Angeles during WWII, Mother Daughter Traitor Spy is a powerful portrait of family, duty, and deception that raises timeless questions about America--and what it means to have courage in the face of terror. **Evening Books** will gather Monday, March 24, 2025 at 7:00 p.m. to review <u>Behind Every Good Man</u> by Sara Goodman Confino.



It's a doozy of a bad day for Beverly Diamond when she catches her husband, Larry, in a compromising position with his secretary. What's a DC suburban wife to do with a soon-to-be ex, two young kids, and no degree or financial support in 1962? Beat the louse at his own game, that's what.

Larry runs the Maryland senatorial campaign for the incumbent candidate projected to win against his younger underdog opponent, Michael Landau. But Beverly has the pluck, political savvy, and sheer drive to push Landau's campaign in a successful new direction, even if he already has a campaign manager who is less than pleased she has inserted herself into the race.

Now it's rival against rival. She and Michael do make a great team...maybe in more ways than one. But with the election heating up, she needs to focus on one thing at a time.
